## **RESOLUTION DESIGNATING LOCATIONS TO POST NOTICE AND MEETINGS DATES IN 2016**

WHEREAS, pursuant to Section 24-6-402(2)(c), C.R.S., notice and, where possible, the agenda of the Woodmen Hills Metropolitan District ("District") Board of Directors meetings at which the adoption of any formal action is to occur or at which a majority or quorum of the body is in attendance, or is expected to be in attendance, shall be posted within the boundaries of the District at least 24 hours prior to each meeting at a location designated at the first regular board meeting of each year; and

Notices of meetings (regular, special and study session) of the Board of Directors of the District required pursuant to Section 24-6-401, et seq., C.R.S., shall be posted within the boundaries of the District at least 24 hours prior to each meeting at, as a minimum, the following location within the District boundaries:

Notices of meetings (regular and special) of the Board of Directors of the District required pursuant to Section 32-1-903(2), *et seq.*, C.R.S., shall be provided to the El Paso County Clerk and Recorder's Office and posted within the boundaries of the District at least 72 hours prior to each meeting at the following locations within the District boundaries:
  - a. West Recreation Center, 11720 Woodmen Hills Dr., Falcon, Colorado
  - b. East Recreation Center, 9205 Meridian Ranch Blvd., Falcon, Colorado
  - c. District Offices, 8046 Eastonville Road, Falcon, Colorado
- 3. Regular meetings of the Board of Directors of the Woodmen Hills Metropolitan District will be held at the West Recreation Center, 11720 Woodmen Hills Dr., Falcon, Colorado on the fourth

Thursday of each month, from January through October, and on the third Thursday of November and December, at 6:30 p.m.
